Please note that the institute must select those students who have completed the academic and other requirements to fill up the online environmental examination form, only after selecting the list of students, a link can be sent to the students at their registered mobile numbers. **All students should fill the environmental examination form through online mode only.**
- The forms, remaining if any will be accepted after the expiry of last date of the late fee, with super late fee of Rs. 1500/- These forms will be accepted in the university examination office provided that the application is forwarded by Principal/ Director.
- Fee report should be downloaded from the **online system** and the same should be submitted to the University Examination Section with the prescribed fees within two days from the expiry of the last date of accepting examination forms.

 - vi. Latest chrome/edge browser
 - vii. Uninterrupted power supplySmart phone (Mobile) :

Any smart phone with Android-Version 7 or higher or IOS -Version 11 or higher.

- 4) No request for any special concession such as changes in time or day fixed for the university examination on religious or any other ground shall be granted
